Memo samples need not be backed for testing purposes, however, a light acrylic or latex backing is required on all COM shipped to izzy+ for production use (with the exception of Sylvi, Nemo Trellis, Evan, Snap, Dewey Connection Cart and KEEL where backing is required on a case-by-case basis). Approval of application does not waive the need for backing, all COMs require backing regardless of approval for application. If yardage is received at izzy+ for production use and is unbacked, fabric will be sent out for backing to be applied at a charge of \$3 net per yard and \$30 net service charge per COM colorway. A minimum of 5 yds is required for backing.

COM/COL purchase orders are excluded from izzy+ warranty. izzy+ is not responsible for any COM/COL wear, defects, appearance, or any other physical attribute of the COM/COL. The customer is responsible for providing material that meets any state or federal codes or laws. It is assumed that the customer has inspected any fabric submitted for COM/COL purchase orders.
